## Galt Collegiate Institute & Vocational School CO-CURRICULAR CODE OF CONDUCT

It is a privilege to represent Galt Collegiate in the co-curricular program. With this privilege certain responsibilities are attached. Every Galt participant is expected to adhere to the following co-curricular code of conduct.

- 1. Participants should conduct themselves as suitable ambassadors for Galt Collegiate at all times. All students are responsible to the school's administration for their conduct at all school events.
- 2. Assignments due on the day of an activity <u>MUST</u> be submitted to the teacher (their mailbox) prior to departure.
- 3. Only full-time students may participate in interschool sports. WCSSAA does consider students who have achieved 22 credits and taking 2 courses/semester as full-time, but at GCI, full-time status is considered 3 courses/semester.
- 4. Achievement and attendance must meet with the expectations of individual teachers.
- 5. Strict adherence to rules while on buses or visiting other schools is expected. Inappropriate language will not be tolerated. Students should dress appropriately for activities away from the school.
- 6. Good sportsmanship means showing respect in dealing with teammates, coaches, opposing teams, officials, and spectators. Galt players will display good sportsmanship at all times.
- 7. All students must purchase a student activity card to help defray the cost of activities. (Those involved in athletics must pay an additional athletic fee.) Students are expected to pay the fees prior to the first competition in order to be eligible to participate.
- 8. In order to participate on a specific school activity day, students must be in full attendance, unless alternate arrangements have been validated by the activity's staff sponsor with the knowledge and support of the vice-principal (i.e. a doctor's appointment.) Students must participate fully in all classes on activity days.
- 9. Team uniforms in athletics are to be worn for team activities <u>ONLY</u>. Team uniforms must be returned in good repair and washed.
- 10. All injuries must be reported to the teacher or coach in charge.

## CODE OF PLAYER CONDUCT

## COMMITMENT AGREEMENT

Once the commitment to a school team has been made, a player must follow through with this commitment. It is unfair to teammates and coaches to leave in mid-season. It is also unfair to other aspiring players who have failed to earn a place on that team. Therefore, any player who quits a school team during the season will be ineligible to play on any Galt Collegiate school team for the remainder of the school year. An exception to this general rule can be made if the coach and player in consultation with the Head of Physical Education and his/her administrator reach a mutual agreement that the departure of the player is in the best interest of all concerned. Any absences by the athlete from practice or games must be discussed with the coach beforehand or as soon after the absence as possible. Excessive absences could lead to removal from a school team.
